Why?





- The MoU was originally written nearly 30 years ago
- It has been patched extensively, most years, but never rewritten
- It is very complex, heavy use of cross-references, very hard to read and over time gaps has emerged
- It is often very prescriptive of operational detail and business processes, some
  of which are obsolete and not followed







- It contains no legal support for external product definitions or limitations on what can be expected of those products
- It's a weird mix of membership agreement and Terms & Conditions for services
- Standard contractual legal protection for LINX and members is absent
- The current MoU isn't fit for purpose for LINX of today and for the future
- Members have from time to time raised issues with the MoU







# Goals







- Improved document architecture
  - Move service specific terms to T&Cs for services
  - Move rare or specific cases to separate documents
  - Members only need read documents relevant to them
  - Separate the legally important from the operational/process guidance
  - Cross-reference documents, not clauses
- Clear layout and plain English
- A new framework agreement that supports both the core relationship and service terms for each service
  - Improved legal structure for both LINX and members' protection
  - More flexibility to continue to add value for members





## **Process**

# What We Propose





# New agreement architecture

- A new Membership Agreement to replace the MoU (one document)
  - The core contractual relationship between LINX and each member
- Service Terms: a separate document for each service
  - Sets out the service description explicitly as well as terms and essential requirements particular to that service
- Special Terms that apply in particular circumstances
  - A document setting out what's different for members joining through a Connexions partner
  - Documents with terms specific to IXPs in Kenya or the USA, or a particular datacentre
- A simpler agreement architecture allows us to provide practical guidance on:
  - Technical e.g. what optics are supported where
  - Commercial e.g. can I pay by credit card? In US\$?







## Member control

- The Membership Agreement can only be changed with a member vote to approve the new version, as with the MoU
- There is a set of documents in the agreement that continue to be under the control of members
  - The core agreement
  - One additional policy: the policy on what kinds of network monitoring LINX is permitted or prohibited to perform will remain subject to member ratification.

#### Other documents:

- Terms for particular services can be changed by LINX generally with member feedback
  - These aspects are mostly currently undocumented, and what is documented in the MoU isn't always accurate or current
  - Members accept these terms by ordering services, and can reject them by cancelling orders
- This structure makes the Member services agreement more like a standard MSA
- Published guidance documents will provide more transparency and clarity on operational processes and technical requirements / supported configurations

  - We are very happy to discuss the thinking behind each provision in consultation meetings or individually
  - We encourage you to discuss proposed changes before making written submissions
- Likewise, we need to understand the thinking behind any concerns you wish to raise
  - Changes are most likely to be incorporated if we understand clearly both why the change is needed and what the intended outcome is, not just the proposed text edit


- We are scheduling dedicated consultation events
